# **Franklin Center & Ripon Society Hold Policy Conference Looking at U.S.-Argentine Relationship**

WASHINGTON, DC - The Franklin Center and The Ripon Society held a policy conference in Buenos Aires from November 9-13 looking at some of the key issues impacting the U.S.-Argentine relationship. Called the TransAmerica Capital to Capital Exchange, the conference included keynote addresses and panel discussions on such topics as transportation security, nuclear non-proliferation, tax reform, biotech research, and energy production.

**Participating** discussions the were representatives from Argentina's public and private sectors, and Members of the United States Congress, as well. The Members included U.S. Representatives Fred Upton (MI-6), Spencer Bachus (AL-6), Luis Gutierrez (IL-4), Frank Lucas (OK-3), Pete Sessions (TX-32), Greg Walden (OR-2), Shelley Moore Capito (WV-2), Mike Rogers (MI-8) Doug Lamborn (CO-5), and Pat Tiberi (OH-12), who served as Co-Chair of the policy conference along with former Ambassador and Representative Connie Morella (MD-8).

addition to taking part in the speeches and panel discussions, the U.S. Representatives also meetings with top Argentine government officials, including Foreign Minister Hector Timerman and President Cristina Fernández Kirchner. According to Jim

Conzelman, the President & CEO of the Franklin Center and Ripon Society, the purpose of the meetings and panel discussions was to gain a better understanding of Argentina at a time when trade with Latin America is of increasing importance to U.S. economic growth. "Argentina presents the United States with many challenges and opportunities," Conzelman stated. "The goal of the policy conference was to learn more about these challenges so these opportunities can be fully realized down the road."




